USES 3 x AA (1.5V) size batteries.

- Non-rechargeable batteries are not to be recharged.
- Rechargeable batteries are to be removed from the toy before being charged.
- Rechargeable batteries are only to be charged under adult supervision.
- Different types of batteries or new and used batteries are not to be mixed.
- Only batteries of the same or equivalent type as recommended are to be used.
- Batteries are to be inserted with the correct polarity.
- Exhausted batteries are to be removed from the toy.
- The supply terminals are not to be short-circuited.

- Keep hair out of reach of the motorized wheels to avoid entanglement.
- Should hair entanglement occur, press the front button again to stop, or shift to "Free Wheel Mode", gently pull entangled hair free.
- Ensure that the train is turned off when not in use.
- For easy assembly firmly connect train cars edge to edge, pull gently to disassemble.
- The train will automatically turn off after 20 minutes. Press the roof buttons to start again.
